



Trip Terms & Conditions

LINX ENTERTAINMENT's ski trip is subject to the STATED conditions. Payment and cancellation policies must be fully understood by all prospective participants. Please read this reservation form to ensure accurate understanding.

ELIGIBILITY: Participation in this trip is limited to all participants. All participants must be at least 21 and over, in order to attend.

FULL PAYMENTS

Full payments ensure that your accommodation are guaranteed and confirmed and provide you with additional amenities, privileges, and treatment and goodie bags. Everyone loves goodies.

DEPOSIT AND PAYMENTS SCHEDULE: This trip requires a non-refundable deposit to confirm the reservation until a certain date as established. Payments are stated in the published schedule found in the ski trip reservation form and trip advertisement flyers.

TRIP CANCELLATION AND REFUND POLICY: The price of this trip is based upon approximate prices and if, prior to departure, the price varies, there may be a refund or an additional cost. In the event that Linx Entertainment cancels the trip, the trip coordinator will contact each participant and a full refund will be given. When the participant makes the cancellation, it is the responsibility of the participant to notify the trip coordinator before the non-refundable date expiration. To substantiate the date of cancellation, all cancellation requests must be submitted in writing and must be verified by the trip coordinator. If full payment or written notice is not received by the non-refundable dateline, deposit and all payments made will be forfeited. If written notice is received before the established non-refundable date, refunds will be made, less any cancellation fees, which Linx Entertainment is unable to recover. In the event that a participant cancels after the established non-refundable date, a refund will not be made until the actual unrecoverable expenses incurred have been determined. Such determination may not be possible until determined by the collective sum of affiliated partner coordinating the effort of the trip.

TRIP PARTICIPANT'S RESPONSIBILITY: The Participant assumes the risk of all baggage and personal items, which the Participant brings on any Ski Trip. Linx Entertainment is not liable for lost or damaged baggage, or other personal property, which the Participant deemed necessary or useful for the trip.

PARTICIPANT WAIVER OF LIABILITY: Linx Entertainment acts only in the capacity of Trip Captain for each Participant. The Participant acknowledges that the Promoters, Trip Coordinators of Linx Entertainment are not liable for any personal injury, including fatal injury, because of any accident or acts of God. The Participant acknowledges that Linx Entertainment. is not liable for; (1) any illness or property damage during the trip, and (2) any delay or irregularity which may be occasioned, and (3) any defect or failure of any vehicle or other mode of transportation through the acts or negligence of any person engaged with carrying out transportation arrangements for the trip, whether associated with the trip or not. The undersigned also acknowledges that Linx Entertainment is not responsible (1) for lack of snow, and (2) for the non-operation of lifts at the destination Ski Resorts, and (3) for any unexpected expenses as a consequence of incimate weather or road conditions and (4) for any acts of God.
